

SPONSORSHIP CONTRACT

GIVEN the notice published on the website of the Embassy of Italy in Zagreb regarding the sponsorship procedure for the initiative "Celebration of the Italian National Day 2026 in Zagreb"

FOLLOWING the contacts established between the entity/company..... and the Embassy of Italy in Zagreb;

GIVEN the offer submitted by the entity/company

Between the entity/company..... (hereinafter referred to as *Sponsor*) represented by, and the Embassy of Italy in Zagreb (hereinafter referred to as *Sponsee*) represented by the Ambassador to Croatia Paolo Trichilo, the following is established:

ART. 1

OBJECT OF THE CONTRACT

Sponsorship through a monetary support from the Sponsor in favour of the Embassy of Italy in Zagreb for financing the initiative "Celebration of the Italian National Day 2026 " and the attribution to the sponsor of the benefits deriving from the defined participation method [*membership/partnership/sponsorship/coproduction*].

ART. 2

DURATION OF THE CONTRACT

This contract is effective from the date of the signing by the parties until the conclusion of the initiative "Celebration of the Italian National Day on 2nd June 2026".

ART. 3

FINANCIAL CONTRIBUTION

The monetary contribution shall be established between the parties in Euro [*indicate amount*].

ART. 4

PROCEDURAL RULES AND GUARANTEES REQUIRED

The contribution referred to in Article 3 shall be paid into the bank account of the Embassy of Italy in Zagreb, HR24 2340 0091 1700 1011 1, open with the bank Privredna Banka Zagreb (PBZ) no later than 20.05.2026.

ART. 5

LEGAL DUTIES AND RESPONSIBILITIES OF CONTRACTING PARTIES

By signing this contract, the parties commit to what is indicated in Articles 1, 3, and 4.

ART. 6

PERSONAL DATA PROCESSING

Personal data will be processed exclusively for the purposes set out in this contract and in compliance with current Italian regulations.

ART. 7

CONTRACT TERMINATION FOR BREACH

This contract shall be terminated in the event of failure to fulfil obligations by either party under the previous articles. The *Sponsor* who has fulfilled its obligations will be entitled to a refund of the contributions already paid. The *Sponsor* shall be liable for damages arising from the failure to comply.

ART. 8

RIGHT OF WITHDRAWAL

The Embassy of Italy in Zagreb has the right to withdraw from this contract at any time. In this case, the *Sponsor* will be refunded the contribution already paid.

The Embassy reserves the right to withdraw from the contract for reasons dictated by foreign policy, upon a simple request, without conditions or limitations of any kind, at no charge, and without questioning the right to a refund of the instalments paid in advance.

ART. 9

COMPETENT JURISDICTION/ DISPUTES

In the event of disputes, the competent court shall be the Court of Zagreb (Croatia).
